KELLER'S GOT TALENT ART SHOW GUIDELINES

Artists must submit their completed application forms and non-refundable entry fee payment by September 6, 2016 in order to participate in the 2016 Keller's Got Talent Art Show. The entry fee is \$20 for up to two (2) pieces of art. Artists may submit up to two (2) more pieces for an additional charge of \$10 per piece.

- All art media is acceptable and must be "family appropriate;" no sexual, bloody or violent content shall be allowed. Subject matter **may not include copyrighted materials or characters**. The Keller Public Arts Board has sole discretion of the display and sale of all art in Town Hall.
- **All pieces must be the artist's own original artwork.** Duplicate, replica or giclée pieces will not be accepted or hung. All sales will be assessed a 20% commission fee by the City of Keller.
- All artwork must be framed and/or finished around the edge and **wired for hanging** with appropriate wire to hold piece.
- City of Keller staff shall determine display locations for all pieces. Any piece that may cause a safety issue to employees or the viewing public, as determined by staff, will not be displayed. Artwork will be hung by City of Keller staff.
- Artists must adhere to the attached show schedule for delivery, pick up and artist's reception coordination. Artwork, including pieces sold during the show, may **NOT** be removed or replaced during the show dates. **NO changes will be permitted after the application deadline indicated on the monthly show schedule.**
- The City will receive 20% of the purchase price for any artwork sold during the show dates. All sales must be cash or check (made out to the artist) and must be processed by city staff. It is the responsibility of the artist to inform city staff if sales tax should be charged on their work and to clearly mark any pieces not for sale.
- City staff will create identification cards and price list, and put show details on the city's website based on information provided by the artist. Any additional advertising will be at the artist's expense.

This agreement is binding on me, my heirs, executors and administrators.
